The Organization's articles of incorporation and bylaws were amended during the year ended December 31, 2025. The articles were amended to indicate that the Organization is now classified as an association of churches. The principal office and mailing address were updated, an association of churches article was added, and the purposes article was modified to include additional detail. A membership article was added indicating the church shall have no corporate members with voting rights, and the current resident agent name and address were updated. Moreover, a board of directors article was added outlining the respective powers and limitations. The list of directors was updated, and articles of indemnification, construction, and amendments were updated. Amendments to the articles require a vote of two-thirds of the members of the board of directors.

The Organization's bylaws were amended to indicate that the Organization is now an association of churches and shall comply with the related requirements. An article regarding an association of churches was added, and a detailed statement of faith and beliefs was incorporated as well. The articles were updated to indicate that the Chairperson of the board of directors has sole discretion to appoint an appointee. The articles were also updated to indicate that directors should discharge their duties in good faith, reasonably, and with ordinary care. Moreover, a note was also added indicating that the highest ecclesiastical tribunal of the Organization shall be the board of directors. Information regarding memberships, deadlock in board votes, and voting by proxy were added. Limitations on committees' powers were also detailed, as well as the responsibilities of an independent compensation committee. Types of transactions of the association of churches was also detailed and an article regarding emergency powers and bylaws was added. Articles detailing the Organization's purposes, its powers and restrictions, and miscellaneous provisions were added. Lastly, the Organization's conflict of interest policy and whistleblower policy were incorporated into the amended bylaws.
